- Formalise our partnerships through MOUs with:
   The NSW Department of Education (DoE)
  - The Public Education Foundation (PEF)
  - Stewart House
- Initiate and support the international recognition of individual NSW public schools through their success in the *World's Best School Prizes*
- Celebrate the first annual *IRSEA Fellowship* awarded to an outstanding senior educational administrator in partnership with the DoE. (This Fellowship is made possible through a generous donation from our Vice President, Dr Kerrie Ikin)
- Establish closer links with the tertiary sector to support a more seamless trajectory of school students to higher education
- Establish links with key Guild leaders within the Australian Film and Television Industry to leverage their cultural, economic and societal influence in strengthening the depiction and perception of the value of public education and TAFE in NSW

While these focus areas and work streams for the year of my presidency are many and, in some cases perhaps even contentious, they are presented as an earnest and strongly held set of priorities based on our work to date and on the principles and values we collectively espouse. Together, with all the intellectual and persuasive power we are able to muster, I believe we can help take public education and TAFE to the levels of success our great democratic society sorely needs.

# Department of Education ANZAC Remembrance Ceremony Teachers and the RSL – Hetty Cislowski

IRSEA member, Hetty Cislowski, presented this powerful speech at this year's DoE ANZAC Remembrance Ceremony on 23 April. She commemorated the original Anzacs and the many men and women who followed in their footsteps, then recounted her own moving story as a World War 2 refugee.

I begin by acknowledging the Traditional Owners of the Land on which we meet today, the Burramattagal people of the Dhurag Nation. This place where we meet today, was initially referred to as part of Rose Hill, but in in 1791 Governor Phillip changed the name of this part to Parramatta, to recognise Indigenous history and ownership. If you say Burramatta quickly it's easy to imagine how it became Parramatta. It was the first time in Australian history that a place name had been selected by the colonial government to acknowledge our Indigenous people. Now, that's special.

Today, I also acknowledge the work of Ken Stevenson and senior officers of our Department who have ensured that the war service of teachers and officers would continue to be recorded, displayed and respectfully integrated into the Department's state office.

We are all here to recognise and respect the spirit of the Anzacs and the many thousands of men and women who have followed in their footsteps in other places of war. We honour their love of country and their belief in democracy, decency, fairness and mateship. As we reflect on the decades since the Gallipoli landings, it's a truly dreadful fact, that wars continue to be part of human history. Sadly, we have ongoing wars in several parts of the world at this very moment.



Today, I have chosen to share with you part of my own story as a World War 2 refugee which is connected to that of an Australian airman, Flight Lieutenant George Kiddle.

#### But first, some context:


In the last months of World War 2, there were already millions of displaced persons (DPs) churning around Europe, many moving westwards on foot, by horse and cart, lucky ones on bicycles, even better if you could hitch onto a truck or train. The tide of DPs increased every day – people looking for loved ones, seeking what remained of their homes, and many needing food, shelter and safety.

My father, Zygmunt, was one of those walking west. He had been part of the Polish resistance, and that

made him a marked man. Then, under German Occupation, he became one of the thousands of Poles to be forced labourers on farms or factories in East Germany. When his first assignment as a forced labourer came to an end, the bureaucratic machine of the Reich re-located him to another farm in Northern Germany. There he met Martha who was also a forced labourer, but from the Netherlands. Their job was digging blocks of turf, to be dried for winter fuel.

Six months after the official end of the war, many people had been repatriated back to their home countries, but there were still about 5 million persons who had nowhere to go, including Zygmunt and Martha. They were now "free", but no longer able to stay on the farm, and afraid to return to Poland. They married and they registered as DPs, the first step towards status as a refugee. They depended on the Allied forces and humanitarian organisations for food and shelter.



#### Now let me introduce you to George Kiddle.

George's father Edgar Kiddle served as an ANZAC at Gallipoli and then in the Battle of Passchendaele.

Returning to Australia, he married and had one child, George. George was a bright kid and did well at school. On leaving high school, George entered the public service and joined the Department of Air which dealt with wartime aircraft.

In 1942 he enlisted in the air-force and trained as a Navigator. He was posted to the RAF Sunderland Squadron in Northen Ireland - then to Oban in Scotland, where he joined the RAF Coastal Command, flying daily reconnaissance, tracking shipping, and hunting U-boats.

At the end of the war, George was de-mobilised and waiting in London for a boat to take him home. Not many boats were available, given the heavy loss of shipping during the war and it would be a long wait for many. By chance, at Australia House one day, he saw a job ad for positions in the Australian Immigration Department - London Office. Keen to do something useful, George applied and, as he still had status as a public servant, he was immediately accepted, promoted a few grades, and began work on the program for selecting British immigrants. He did this for about 18 months.

Then, in 1947, when Australia decided to accept DPs from Europe, George was asked to develop the forms and selection procedures, and then to implement the program in cooperation with the International Refugee Organisation (IRO). His was a small team: just 3 blokes plus Miss Watkins, the Secretary/Typist. They hired local translators and drivers to get them around the camps.

Now\_let me bring these two stories together – my family, and George Kiddle

In 1947, Zygmunt and Martha were in one of the largest DP camps. Diepholz. I was born there. The camp had many long wooden huts which had previously served as barracks for German soldiers, also POWs, and for some time as a holding station for Jewish people being transported to the death camps.

This is how George described it when he went there to select people for his first shipload of immigrants: "... the conditions in Diepholz were worse than in any of the ordinary DP camps I went into to... and the food, well, there was hardly any of it ...". The impression he had of DP soup was "like a cauldron of boiling water with a turnip dragged through it".

George and team were working at a cracking pace. He claims that once they processed 139 applications in one day! Securing ships for the long voyage to Australia, however, was a major set-back. Finally, his first shipload set off in December 1947. Happily, from then onwards, more and more ships became available and in the next 4 years 149 voyages were made, carrying DPs to Australia.

Zygmunt and Martha made their application for us to immigrate to Australia on 27 April 1948. I was just one year old. We had many medical assessments and interviews. My parents also had to provide character references, but I did not have to – I was assumed, quote, "to present no risk to the Australian Government".

We were notified as "eligible" when I was nearly two years old. Finally, the notice we had been waiting for: Miss Watkins sent us our "Acceptance" papers on 19 January 1950. Our ship was the Fairsea. It carried almost two thousand immigrants, in hammocks, with separate decks for males and females.

We departed from Bremerhaven in Germany on 18 April 1950, sailed through the English Channel, the Mediterranean and then into the Suez Canal. As we eased ever so slowly through the canal, the hawkers on the shore hooked up a sort of pully system in which trinkets and souvenirs came up and the passengers sent down a bit of money. It was my third birthday now and my parents sent down a small coin which was enough to buy an orange. The orange was very special to me, but I would not eat it. I just carried it around the deck each day, sniffing the perfume, enjoying its roundness and bright colour.

A few weeks later we disembarked in Melbourne. Unfortunately, even though the orange was still intact, the customs official there snatched it from my hand, chucked it in a bin and said firmly, "You can't take that in 'ere, Luv".



From Melbourne we went to Bonegilla Camp, near Albury, for two weeks of basic English. Zygmunt was then assigned to a group bound for the BHP Steel Works in Newcastle. We had a long rail trip followed by a bus trip in the dead of night, on a rough road, with no signs of habitation. It was very dark when we arrived. The accommodation was Nissan huts on the site of an abandoned naval station. There was an air of anxiety - it felt a bit like where we had all come from. The next morning, we were woken early by the laughter of a rowdy family of kookaburras, followed later by beautiful birdsongs from magpies and currawongs. The sky was endless blue, blue sky such as we'd never seen before. The light danced on the waters of Shoal Bay. And, there were bowls of oranges on the tables.

The horror of war, and uncertainty and shame of being a refugee, were replaced by hope and, for most of us in 1950, boundless opportunity. In total, Australia accepted over 182,000 refugees in the first five years after WW2. I was so lucky to be one of those. My thanks to George Kiddle, and his small team, including Miss Watkins, whose neat signature is on my papers. And my thanks also to the National Archives of the War Museum for the documents I have been able to access.

From my early days at school, New Lambton, Kotara and Hunter Girls High, I participated proudly in every Anzac Day Ceremony. I was very often the chosen student to say the Ode, or to speak about human sacrifice. I was proud to become a teacher in DET, and then a senior officer and ADG.

After my retirement from DET, I spent almost 20 years as an education adviser to Australia's Aid programs in the Asia-Pacific, including Papua New Guinea. On one visit to PNG, I was privileged to attend the Dawn Service at Bomana, which holds the graves of 3,826 service men who died in the fighting in Papua and Bougainville. I was very moved.

They gave their service, and lost their lives.

So very close to home.

Lest we Forget.

# Schools Roadshow at Figtree High School 13 May 2025

Raechel McCarthy, R/Director Delivery Support Group 4, reports on an important event highlighting and shaping future directions for NSW Department of Education and public schools.

Staying deeply connected to what is working and can be improved in our public schools is very important to our Secretary, Murat Dizdar – as it does indeed for IRSEA members. The Schools Roadshow provides a valuable opportunity for the Secretary and the Executive leadership team to connect with school leaders and staff across the state and discuss how we can deliver together on Our Plan for NSW Public Education. Every year the senior leadership team visits 10 new school locations across NSW to host these roadshows and there is very high attendance at each of these events.



I was fortunate as DEL to be able to showcase the work of Cringila PS, Figtree PS and Figtree HS by these schools hosting visits prior to the roadshow. These schools are all making strong strides towards achieving our Department's priority areas of Explicit Teaching, High Potential and Gifted Education (HPGE), and Equity and Excellence.

During the roadshow, our Secretary spoke about:

- Our need to do student wellbeing better including a wider distribution of support classes across schools reducing the need for students to travel away from their local schools.
- More system supports for scope and sequences/save reinventing the wheel and focus more on quality teaching and learning including explicit teaching.

- The need to land more support for staffing in small schools
- The importance of learning from issues created recently in centralising selective schools' tests. The Secretary will be sending personalised letters to all unsuccessful students describing what HPGE activities are offered at their local high school.
- Asking for stronger data points from schools to prove to government the merit in their commitment to increase enrolments
- Mandatory School Development Day 2026 will be on neurodivergent students, inclusion and diversity. This year the focus was on HPGE
- Classroom Career Pathway (keeping good teachers in classrooms)
- The importance of leaders balancing trust and credibility as leaders.

During the afternoon session there were roundtable discussions getting feedback from schools on the following issues impacting their schools and suggestions for solutions.

- 1. Workload reduction
- 2. Technological impact and support (including the influence of AI)
- 3. HPGE
- 4. Community and family engagement
- 5. Zoning / transitions / enrolments / market share
- 6. Behaviour and attendance
- 7. Staff wellbeing.

Overall, the day was highly successful and reinforced for me the positive direction our Department is taking using a positive mindset and pragmatic approach to addressing key issues impacting our success as a system.




# **REPORT: Consultation on the New IRSEA PLAN**


To what extent does the plan clearly reflect and communicate the constitutional *objectives* of IRSEA?

To what extent can the plan guide IRSEA to have significant positive impact for its members and for public education in the future?




Rightly, the only amendment required was to explicitly include IRSEA's commitment to supporting and advocating for students and young people accessing TAFE provisions.

# **COMMITTEE REPORT UPDATES**

#### **Treasurer's Report: Ray Gillies**

On 16 May 2025, the IRSEA Society Account had a balance of \$14,649.34. This included advance payments for the IRSEA meetings on 30 May in Sydney and on 14 June in the Hunter Valley. These funds, totalling \$1,145, will be paid out to the venues in due course.

IRSEA receipts included \$2,605 members' subscriptions; \$2,992 in members' Stewart House donations (due to be forwarded); and \$155 other donations.

Expenditure consisted of AGM lunches \$2,040; March newsletter \$406.34; certificates \$165.10; NSW Fair Trading \$56; and postage \$30.

Our Term Deposit is valued at \$10,775.51 (maturing 14 July 2025).

The Annual General Meeting on 21 March 2025 approved the proposed increase in the IRSEA annual subscription to \$30 in 2026.

# VALE ERIC FLOOD

On 28 April, one of IRSEA'S older members, Eric Flood OAM, sadly passed away. Eric was well known in education circles but was also well known as one of the oldest living veterans of World War 2.

Eric was born in 1925 at Yenda, a place near Griffith. and started teaching in 1949 following his army service. He went to Sydney BHS, and when he left he got a job in the Irrigation Commission, before joining the army at 18. His time in the army is well documented and his story is available from the Australian War Memorial sound archives. On Eric's return from war, he had a calling to teach, went to Sydney Teachers' College, got married, and then started teaching, in his words, all over NSW.

He became a school inspector in 1969 in the Lithgow area before moving to Mortdale inspectorate in Met East in 1973. He was the Director of Services, 1977 -1982, spending the last three years of his education service as an Inspector in the Engadine area. He retired in 1985.

He was a tough old guy and lived in the Central Coast area. He was 4 months short of his 100th birthday when he fell, retrieving his walker from the boot of his car (yes, he will still driving his own car) and did not recover from the injuries he sustained.

In 2024 Eric was awarded an Order of Australia Medal for his service to veterans and their families. It was appropriate that on Anzac Day this year, Eric delivered the Ode of Remembrance at the ceremony at Tarragal Glen Retirement Village, as he had done for many years.

Eric was a strong supporter of Legacy in his retirement as he had great empathy for veterans and their families.

How proud we are of Eric...100 years old (nearly) and a life of service to his country, to public school students and to Legacy.

Thank you, Eric, for everything. you have done in your life and now it is time for a rest ... although I doubt whether he even knew the meaning of that word!

## VALE TONY RE

On Friday 21 March, the AGM for IRSEA was held, and unfortunately there was a spare chair ... our colleague and friend, Tony Re, had passed away earlier that morning. We were in shock, as Tony was a happy, positive member who loved these gatherings.

Tony was born in Sydney in 1938. He went to Sydney BHS before teacher training at Balmain Teachers' College. He was appointed to Tallong PS for his country service before heading back to Sydney where he taught at Maroubra PS and Glenmore PS. Tony studied at UNE externally before accepting Principal positions at Newling PS (Armidale), Chifley PS and Bankstown PS. He spent some time on behalf of the Department as a Senior Teacher Advisor for Scholarship students at the University of New England. He became an Inspector, then a Cluster Director, before finalising his career as a Director of Quality Assurance (1995-6).

A little disenchanted with the number of restructures, he decided to retire at the end of the Quality Assurance role. He continued to contribute to education as he was a highly regarded leader amongst leaders whom he guided and mentored. Tony wrote many articles about leadership, but a great memory many of us have regarding his literary skills is of his "Letters to the Editor". I remember flicking through the paper to find his opinion letters and he soon became part of the SMH Fraternity, destined to entertain, enlighten and educate others about public education in particular. In my talking to other colleagues, I learned that Tony was described as a "fit bloke who ran many times in the City to Surf for the DET"; "a cheerful, cynical guy"; "a passionate public education advocate, strong-minded, who held very strong political views".

I P President Gerry remembers Tony as the first person to welcome him into IRSEA, and when they made the connection that he and his Jon taught together, there was an instant rapport. Outside of education, Trevor Wootten, great mate of Tony, tells me that they have known each other for more than 70 years and met playing cricket in a church cricket team. They worked together, travelled together, shared stories and enjoyed each other's company. Trevor will miss him as he was a "great bloke."

In reading all this, it probably doesn't fully complete a picture of someone who was a good and well-respected man. Public education was the winner in his story because not only did he spend many years being part of it, but he also spent many years as its advocate. We appreciate this so much as we all try to be advocates for a system that needs every one of us speaking up strongly. One voice is now gone, so we owe it to him to speak louder!

Thanks, Tony, for a wonderful career that has had an impact on many.

# VALE MANDY TUNICA

On 1 May, we received the very sad news that another former member of IRSEA has passed away.



# PRESIDENT'S REPORT

Gerry McCloughan



Dear friends and colleagues

Thank you for your support to me in the President's role over the last 12 months. It has been an honour to serve this exceptional organisation. I have enjoyed contributing to advancing the Institute's mission and planning for its sustainability as an organisation. I am proud of what IRSEA has achieved over the last 12 months and I pay tribute to the hard working Executive Committee for their time, enthusiasm and advice.

There is much for IRSEA members to celebrate as we look back over the last year.

Our four general meetings continue to provide the primary vehicle for face-to-face networking and collegiality. Some stats for your interest – we have had 122 members and guests attending our general meetings, for an average of 30.5 per meeting. 54 people attended one or more meetings. We received over 60 formal apologies. <u>And</u>, <sup>(C)</sup> . . . we should be giving gold stars \*to our 12 members who have not missed a general meeting in the last 12 months!

As always, regular IRSEA communications are superb. Thanks to Syd, Eric, Brian, Ray and Lindsay for work on correspondence – especially the emails, newsletters and the website.

Our guest speakers have been stunning. Thank you sincerely to David Riordan, CEO, Public Education Foundation, for enlightening us in May about the magnificent achievements of the PEF in supporting disadvantaged students and communities across NSW and the nation. Thanks to Viv White AM, Co-Founder and CEO, Big Picture Learning Australia (BPLA) for presenting to us in August with models that can transform learning by placing students at the centre of decisions around what, how and when they learn. I acknowledge the ongoing Custodians of the lands on which IRSEA members reside and meet. I pay respect to Elders past, present and emerging and commit to promoting improved education and life outcomes for Aboriginal and Torres Strait Islander students and their families.

The December 2024 meeting was a remarkable celebration, with our own Dr Ken Boston AO recounting his '*Ripping Yarns from the files of the KGB*'. During this meeting, we instigated *Your voice matters*, an event feedback survey, and overwhelmingly responses indicated Ken's address as the highlight of the meeting. Well done Ken. Thank you to those members offering ideas for improvements for our meetings—the Committee has taken note!

Today, we are privileged to have our keynote address from one of our dear Honorary members, Deb Summerhayes, Deputy Secretary, Public Schools, NSW Department of Education. Deb's passionate support of our organisation is tribute to efforts of a long line of amazing IRSEA leaders who have been promoting IRSEA's capacity to provide the Department with independent, evidence and experienced-based educational advice, expertise and support to advance public education.

For some time now, Deb has actively supported IRSEA representation in the Public Schools' Capability Summits and regional Hub & Spoke professional development days as a means to share directions and achievements, but also to ensure that current senior officers of the Department recognise the value of connecting the past and the present to help shape the future of public education. I certainly hope that IRSEA and the Department continue to strengthen the ties between our two organisations for the good of school communities and student learning across NSW.

IRSEA continues to acknowledge excellence and dedication of members and colleagues in education. By the end of our meeting, IRSEA will have presented seven awards to extraordinary colleagues over the past year including two Life Memberships, two Outstanding Service Awards, and three Honorary Memberships. Congratulations to all honoured recipients. During our meeting today, Kerrie Ikin will update members on the establishment of a Fellowship for Senior Educational Administrators, a research grant scheme to be jointly funded and awarded by IRSEA and the Department. This is an exciting initiative indeed.

Our general meeting raffles and member donorships have raised over \$3,700 for Stewart House in 2024. We hope to boost that figure today. Stewart House remains the primary charity of the Institute, as it has been over a very long time.

Sadly, eight colleagues have passed since the last AGM. I am acknowledging their passing during the meeting today. Valete to members Roy Knudson, aged 92 years; Eula Guthrie OA, aged 95 years Mervin Blanch, aged 98 years; John Fleming, aged 95 years; John Ward, aged 81 years; John Hoye, aged 94 years; and Joan Healy, aged 87 years; and to colleague Cliff Williams, aged 85 years.

IRSEA continues to attract new members – in the last 12 months over 30 new Full Associate and Honorary members have been accepted to IRSEA. Currently, IRSEA membership is over 140.

During 2024, we were able to increase the number of additional social and professional events. Highlights included:

- re-establishing our IRSEA social luncheon program with an event at the Sydney Rowers Club, Abbotsford in October 2024;
- an amazing tour of the ANZAC Memorial in Hyde Park on 2 August 2024,
- participation in the forum: Where now for Public Schooling in Australia?, held at the University of NSW on Friday, 15 November 2024.

Planning is underway for:

- the next social luncheon to be help at the Sydney Rowers Club, Abbotsford in April or May 2025.
- a Member-seminar being planned for Thursday 22 May 2025 to be held at the University of Technology Sydney Broadway campus. This will be the first of series of member-seminars established to a support our *Thought Leadership* priority 2. The first seminar will be led by member Dr Jim Scott to share his PhD research: *Exploring the impact of a large-scale diagnostic science test and formative practices.* The one-hour seminar will be followed by a social luncheon.

 a Hunter Region IRSEA dinner and meeting to be held at the Apollo Hotel in Charlestown over Friday 13 June (for a social dinner) and Saturday 14 June (for a lunchtime meeting). This initiative aims to expand IRSEA's activities beyond the Sydney metropolitan area. The Friday/Saturday format is designed to allow both Full and Associate members to attend. Laureate Professor Jenny Gore, University of Newcastle, has agreed to be our Guest Speaker for the formal meeting on the Saturday.

Invitations detailing these three events will be advertised to members shortly.

In August 2024, we launched our draft IRSEA Directions and Priorities one-page plan which has been presented to all members for consultation via IRSEA NEWS and email. Thank you to the many members who have responded to the online consultation survey. If you have not had an opportunity to provide feedback as yet, the consultation window is open until 31 March 2025. Hard copy survey forms are available in the meeting today as well. See Gerry.

IRSEA is proceeding to establish formalised partnerships with other organisations in its mission to inspire and support the achievement of equitable outcomes and educational excellence in public education in NSW. Today, the IRSEA Executive Committee is seeking members endorsement for three motions to strengthen the Institute. Motion 2 seeks to progress a non-binding memorandum of understanding with the Public Education Foundation (PEF). I look forward to member support for our important three motions.

I am looking forward to my new role as Immediate Past President and in supporting the incoming Committee under the leadership of my fine colleague and good friend President Lindsay.

# **PROPOSAL TO ESTABLISH NEW POSITION**

# PROPOSAL TO ESTABLISH THE NEW POSITION OF VICE PRESIDENT STRATEGIC DIRECTIONS

#### Purpose

This paper proposes the creation of a new Executive Committee role—*IRSEA Vice President Strategic Directions*—to provide sustained continuity of leadership and management of the implementation of strategic initiatives.

#### Background

In recent years, the IRSEA Executive Committee has undertaken a series of strategic initiatives aimed at expanding membership, strengthening professional networks, formalising our mission, and advocating for Public Education as the preferred provider of excellence in student learning.

This has been driven through the development of a range of strategies to:

- invigorate membership by recruiting a broader membership base featuring a shift in demographics;
- add new opportunities for social/collegial gatherings, experiences and celebrations;
- establish a range of awards and honours for both members and notable others;
- formalise IRSEA's high moral purpose with Mission, Vision and Priority statements;
- · forge pathways to partnerships and coalitions with organisations of shared values and strategic intent; and
- frame its future as a leading advocate and highly influential contributor to support Public Education as the acknowledged provider of first choice for excellence in student learning outcomes.

#### Discussion

The scope, scale, complexity and ultimate success of this comprehensive and integrated set of initiatives will require levels of leadership and management continuity that may be better served through a reconsideration of the Committee profile and terms of tenure.

The added work-load inherent in our expanded focus and commitments has meant that a greater burden of responsibility has been carried by Committee members within a structure which reflected and delivered, more than admirably, for a far less ambitious agenda.

A related challenge is the short tenure of key leadership positions, notably President, Vice President, and Immediate Past President. While there are more than valid and admirable reasons for this 'rotation' of leadership, the one-year term for each represents a challenge for the successful carriage of more complex strategic initiatives that can be more than one, two or three years in their making and realisation.

This issue is amply evidenced by:

- the time-lag in framing more formal arrangements with the retired principals' council and association;
- the time and complexity of negotiating and entering into partnerships with the Public Education Foundation (PEF) and the Department of Education (DoE);
- the logistical and management requirements of extending the scope and range of our meetings to regional areas; and
- the difficulty of, and the effort required in realising our great purpose of supporting the regeneration of Public Education in this state.

We have been well served by the current Executive Committee structure and profile. Officers in Executive Committee roles have been magnificent in their dedication, the quality of their work and the splendid outcomes they have achieved.

This proposal asserts that the already powerful impact of our Committee would be enhanced, and the added responsibilities of our members would be more effectively designed, by adding the position of *Vice President Strategic Directions* to our structure. This position would enable IRSEA to more ably fulfil its noble remit as an acknowledged leader in shaping the new educational landscape while maintaining and growing its highly attractive suite of social/collegial activities for its members.

#### Vice President Strategic Directions – Key Responsibilities

- Support IRSEA's Executive in implementing its strategy, ensuring it is disciplined, achievable, measurable, and sharply focused on the elements most required to deliver the organisation's vision and purpose.
- Guide the development of clear annual priorities, timelines, and success measures to drive effective implementation.
- Ensure the Committee's ongoing and regular focus on success measures to track progress, assess achievements, and inform leadership decision-making.
- Provide structured oversight to maintain momentum on long-term initiatives and ensure alignment with IRSEA's broader goals.
- Facilitate strategic oversight and continuity across leadership transitions to sustain focus and progress on key priorities.

**Note:** This position has no automatic succession right to the Presidency of IRSEA. Only the currently configured Vice President position will assume that role as per usual practice.

#### Recommendations

- The Executive Committee support the establishment of the position of Vice President Strategic Directions at the AGM, March 2025.
- The new position of Vice President Strategic Directions be appointed for a one year term with the same reelection option as per other positions to bring essential continuity to our work for the levels of influence, impact and outcomes we seek to achieve.
- The Executive Committee commence a feasibility process for the optional extension of tenure of the President, Vice President and Immediate Past President positions for 2-year terms.
